This Form of Proxy is solicited by and on behalf of Management of MCAN Mortgage Corporation (the "Corporation").

### Notes to proxy

1. Every shareholder has the right to appoint some other person of his or her choice, who need not be a shareholder, to attend and act on his or her behalf at the meeting. The securities represented by this proxy will be voted or withheld from voting, in accordance with the instructions of the shareholder, on any ballot that may be called for and, if the shareholder has specified a choice with respect to any matter to be acted on, the securities will be voted accordingly.
7. This proxy confers discretionary authority in respect of amendments to matters identified in the notice of meeting or other matters that may properly come before the meeting.
